Introduction of Committee Members

Deans' Reports

- Associate Dean Tom Dana
 - Dean work slightly reorganized.
 - Oversees IT office, ETC, finance and administration, behind-the-scenes operation, and facilities
 - Learning technology focusing on AI
 - IT update: Department is short-handed. Requests patience from faculty. Presently working to hire personnel.
 - ETC update: Course development, promoting faculty research, academic marketing, supporting student activities, etc. This group is expanding on workload, and they are currently analyzing this year's work to determine staffing needs. One of the challenges is that several staff are external consultants, so they are not always readily available.
 - Business office update: Primary challenge is the new budget model that is based on expenditure of all funds, that then taxes you on that total amount. One way to work with this system, without making too many adjustments in-house, is via adjustments to summer instruction. This would help reduce costs.
 - On leave since January 2022. Thank you for support and if you need anything, please reach out.
 - o Elena Anderson is the new assistance for Glenn Good
 - Erica McCray office changed to where Tom Dana's office use to be
 - Jennifer Wrighton and Tom Dana's offices are now under the library (IALT)
- Associate Dean Thomasenia Adams
 - New fiscal year started July 1st
 - o July:

- Nine funded projects that equal approximately \$8.6 million dollars
- 16 proposals, many of which are still pending review
- One active award at this time, which is the International Educator of the Year Award. This award is distributed to faculty, and everyone is encouraged to apply directly.
 - Later this fall, many awards will be announced. Many of these will be internalIf you are eligible, please apply
- o 14 tenure candidates 4 HDOSE, 2SESPECS, 5 STL, 3 PKY
 - Supporting all faculty through this process
 - The timeline includes asking school directors to get the external evaluation letters in for candidates in September
- Faculty interested in conducting outside activity (i.e., not part of your UF workload, but utilizing your expertise/ requiring a time commitment) must submit requests to UF
 - If you are unsure if you need to submit a request, then please talk to the school director or Associate Dean Thomasenia Adams to help make that decision.
- Changes:
 - Post awards moved to OER (who also handles pre awards) to help make work more transparent, cohesive, and fluid. This will help with having a system in place for when you submit proposals.

- Some of Associate Dean Tom Dana's roles moved to Associate Dean Tina Smith-Bonahue's role
- Some of the changes include:
 - Elayne Coloń is now the senior director, which reflects an expansion in her work in academic affairs at the education center
 - Aaron Ganas is now the student affair lead (advising and admission)
 - Suspect that there will be some glitches with the transition. Asks faculty to be partners and provide feedback with these transitions
 - Eddy left to New Jersey
 - Starting next Tuesday (9/6), Catherine Hudson (coming from outside of UF) will be in this role.

 - Big shout out to Lori Dassa and her leadership
- UF initiatives:
 - Focused on students' success at the undergraduate level, and being driven by being in the top five.
 - Improve student retention and speed up graduation for undergraduates

- Updates from Faculty Senate
 - Faculty Senate Meeting notes were sent out via email on 8/25/2022 at 7pm
 - General kick off of the year

Discussion Item

- Discussion: Roles of Deans in FPC meetings
 - Several individuals contacted the Chair and Chair-Elect about this
 - This topic was initially brought up at the last FPC meeting
 - According to UF's and Florida's Constitutions, all faculty members are able to engage in policy making, which includes deans.
 - CBA appeared to be more helpful regarding rights listed for faculty
 - Article 9 bylaws section 1 faculty members of the college, schools, etc. have the right to create bylaws or other written policy
 - Sometimes related to simple majority majority of all faculty, more so for tenures, etc.
 - Where do deans fit in FPC?
 - History of having deans participate in FPC meetings includes to tie loose ends between offices and make sure that information is going in the right direction. If there are questions, they are getting checked on.
 - Also helps with expediting and streamlining certain things.
 - This format is similar to the governance concept and mirrors faculty senate. Most of those are joint committees and outcomes are usually better, timelier.
 - We would have to create more committees if deans were not present at FPC meetings
 - Question: Will there be interest/opportunities for faculty to have discussions without the deans in the room?
 - The Chair and Chair Elect recognize that we are in a bit of a moment with the current climate and faculty may feel unsure on how to talk about certain things when the deans are present. They want to make sure that they are listening to what the FPC faculty are bringing up, and bring it back to the FPC group for further discussion.

- Since the deans are faculty, we would have to ask them to step out if we do decide on this.
- In the past, discussions without the deans were done, it just can't be official, it would need to voluntary and a request to the deans.
- Suggestion to move forward with this, but have the time allocation be uniformed for each meeting (e.g., last fifteen minutes of each FPC meeting the deans can step out as a personal courtesy)
- This topic can be further discussed outside of this meeting with the Chair and Chair-Elect (can be contacted via phone)
 - Julie reminded them about phone number
